BECAUSE OF THIS, EWF SECURED SPECIAL FAA CLEARANCE TO FLY CHARTER JETS INTO PONCE INTERNATIONAL AIRPORT TO CONDUCT EMERGENCY HUMANITARIAN EXTRACTION MISSIONS. MORE THAN 150 CITIZENS WITH SPECIAL NEEDS WERE EVACUATED FROM THE ISLAND AND REUNITED WITH FAMILY MEMBERS IN SOUTH FLORIDA WHO WERE ABLE TO TRANSPORT THEM TO MEDICAL FACILITIES TO RECEIVE URGENT CARE.
